- 2. On an application for <u>ARCHITECTURAL REVIEW</u> of renovations or modifications to exterior elements of existing structures or sites, you must submit:
  - (1) Two (2) copies of scale drawings showing the exact nature and extent of the proposed changes.
  - (2) Two (2) copies of scale drawings showing the relation of the proposed changes to the rest of the building.
  - (3) Material and color samples of proposed new elements.

Uptown Review Board Members and Staff:

This narrative is to support the documents provided within Birdie Books' Uptown Review Board (URB) Application for Certificate of Appropriateness dated, April 15, 2024.

On November 27, 2021, Birdie Books opened a *Pop-Up Shop* in the back of the historic commercial building located at 74 N State St. in Uptown Westerville. This shop was originally meant to be a temporary hold-over while a permanent retail and restaurant location was constructed at 86 N State St., a Victorian-era, single-family home. Plans evolved once it became obvious that 74 N State St. is much better suited for a retail establishment such as a bookstore which also has a cafe experience. Currently, Birdie Books is expanding to include the front portion of the building, which more than doubles the square feet of the book shop. Also, a coffee shop and bar will occupy the north west portion of the building. A Grand Opening is planned for the Fall of 2024.

This URB application includes the first of a series of updates planned for the exterior of the building to support this business concept. The storefront along N. State Street is the top priority. Introducing new signage, lighting and color schemes are vital to establish the permanent presence and purpose of Birdie Books. Simple painted wood block letters are used as the basis for Birdie Books signage above the main entrance. Also, address numbers and "Uptown Westerville" are incorporated in the design to pay homage to our location.

The blade signage above the main entrance is unique in several ways. First, as the historical plaque on the exterior of the building explains, 74 N State St was the original location of the Culver Art and Frame Co. which was founded by Frank Culver in 1902. The artwork depicted in the frame was sourced from an antique shop, and research revealed the artwork was created by Ohio-born artist, William Holbrook Beard (1825-1900) around the same time period as the founding of the building. The artwork supports the Birdie brand with a scene that is open to interpretation, an adventure of one's own, much like the adventures found while reading. The signage is also a subtle nod to the Culver Art and Frame Co. and to the current existence of an art gallery inside the bookshop.

The mural included in this application is in a conceptual design phase. It is offered for conceptual review at this time. The images are specific although color has not yet been incorporated. The mural consists of elements and vignettes associated with a literary journey through space and time. It has several interactive opportunities for the public to engage with the message, creating unique photo opportunities.

The overall design concept presented is mindful of balancing the historic portions of the brick building in the front, with more modern elements, including cinder block construction, in the back. Celebrating these two distinct styles with varying concepts, while creating an overall cohesive aesthetic is the main objective. The front of the building maintains its original early 20th century architectural heritage with detailed wood moldings, original brick, large picture windows and simple signage. Introducing a literary mural on the back of the building amplifies the modern-day spirit and enthusiasm of the Uptown community.

Once the build-out process is complete, Birdie Books will function as a literary and community hub for Uptown Westerville. The cafe will host public events such as poetry readings, story hours, author signings, open mic nights, trivia challenges, book clubs, and team puzzle competitions. During regular business hours, the cafe will offer a unique "unplugged" experience; an environment free of electronic devices, which will further promote creativity, community and personal connection.

Future store hours will be 8 am to 8 pm, seven days a week. A staff of at least 7 Full-time and 7 Part-time individuals is expected.

- 2. Additional Signage
- 3. Covered Patio
- 4. Final Mural Design

## PRIMARY COLOR

The primary color (currently black) of the front facade and all window moldings would be updated to Roycroft Bottle Green.


#### BLADE SIGN

Extending perpendicular from the facade, a sign made of steel and wood would be attached in the center of the building above the main entrance. [More info on pg. 2]

#### PRIMARY SIGNAGE

Lazer-cut wooden letters on a wooden base would be affixed above the main entrance (covering three windows) and painted off-white. [More info on pg. 4]

#### WINDOW GRIDS

Grids would be added to all the windows made from wood and painted green to match the new facade color. Grids will be affixed to the inside of the windows.

#### GOOSENECK LIGHTS

Three gooseneck lights in raw copper would be installed above the "BIRDIE BOOKS" signage for evening & night-time illumination. [More info on pg. 6]




#### PICTURE FRAME MOULDING

Additional picture frame moulding would be added to match the existing moulding and painted to match new facade.

#### BLADE SIGN SUPPORT ARMS

The arm holding the signage would be made of aluminum and painted black. The arm would extend 40" from the building. A smaller support strut, also made of aluminum, will connect to the building diagonally to provide additional support.

#### TOP MESSAGE SIGN


A white sign  $(35"w \times 6"h)$  would be attached above the main support arm featuring a hand painted "COFFEE BOOKS SPIRITS" in Bebas typeface in black paint. The Letters will be 3"h. This sign will be duplicated on both side so it can be read from both sides.

#### FRAMED READING BEARS

Hanging below the main support arm would be a painting (35"w x 27"h) featuring bears that are dancing and reading. This would be printed on weatherproof vinyl and attached to aluminum. The frame would be stained cedar for long-term durability. This frame will be double-sided so passersby can see it from either direction. Note: This painting is originally created by Ohio-born artist William Holbrook Beard (1825-1900). Beard's art is considered public domain (created prior to 1923 and over 70 years since the artists death) deeming it free to be used commercially.

PLEASE NOTE: The Joe's Automobile Repair sign directly north of our building is 48" wide – 8" wider than our proposed sign. [See page 3 for more info]

#### "BIRDIE BOOKS" LETTERS

Prismatic wooden letters in "Cubano" typeface with a beveled feature would be attached above the main entrance of the bookshop and painted Classic Light Buff. The "BIRDIE BOOKS" wordmark would be 15" high x 138" wide.

#### SIGN BASE

The base for the sign would be wood matching the current facade materials and painted Roycroft Bottle Green to match the new overall color scheme. This base would be 24"h x 163"w and would cover the three center windows above the main entrance.

#### "74" & "UPTOWN WESTERVILLE" LETTERS

To pay homage to Uptown Westerville, we would like to feature its namesake and our street address on our front facade. The prismatic wooden letters in "Cubano" typeface would be 4.5"h. "UPTOWN WESTERVILLE" would 80"w and "74" would each be 7.5"w. Letters would be painted Classic Light Buff.

#### PICTURE FRAME MOULDING

Picture frame moulding would be added to frame around the text. This moulding would match the existing molding already present on the front facade.






#### NEW WINDOWS


