21 S STATE ST WESTERVILLE, OH 43081 The proposed additions to the buildings located at 29 and 21 South State Street, as well as the site between buildings, aims to provide a contemporary connection between both structures while incorporating new gathering spaces, and providing additional work space.

The additions take material and design cues from the existing historic building, but seek to contrast with complementary elements. Our goal with these new structures is to activate new exterior spaces at the pedestrian scale while maintaining proportion to the existing building facade, creating new activation space that is inviting to the public.

The new additions intend to respect the history of the site while creating new spaces and moments for the building and residents of Westerville.

PLANT INSTALLATION NOTES

- CONTRACTOR SHALL VERIFY WITH THE OWNER AND UTILITY COMPANIES THE LOCATIONS OF THE EXISTING UTILITIES PRIOR TO STARTING WORK. CALL THE OHIO UTILITIES PROTECTION SERVICE AT (800) 362-2764. CONTRACTOR TO REPAIR ALL DAMAGES TO EXISTING UTILITIES, CURBS, PAVEMENTS, ETC. RESULTING FROM LANDSCAPE INSTALLATIONS WHICH OCCUR DURING THE CONSTRUCTION OF THE PROJECT.
